Please see below financial highlights of Ginebra San Miguel Inc. (the "Company") for full-year 2024:

The Company saw a 17% sales growth to Php 62.5 billion, driven by increasing consumer demand, with a 9% volume expansion, reaching Php 50.6 million cases. Operating income rose 26% to Php 8.6 billion, while net income increased 3% to Php 7.3 billion. Without the one-time Don Papa rights gain in 2023, recurring net income would have risen 22%. EBITDA stood at Php 9.5 billion.

The Company will submit its Annual Report (SEC Form 17-A) including its financial statements as at and for the period ended December 31, 2024, not later than the deadline on April 15, 2025.
